"Public Notice"

Sub: - Generation of Unique Identification Number with respect to Arms licenses on NDAL/NDAL-ALIS website- uploading data thereof.

Whereas, Ministry of Home Affairs Government of India vide notification No. G.S.R 1468 (E) dated 28th November, 2017 received through NDAL/ALIS Portal which reads as "***In the Arms Rules, 2016, in rule 15, in sub-rules (2) and (4) for the figures, letter and words "1st day of April, 2017 the figures and words 1st April 2018" shall be substituted.***

Whereas, it was made known by the medium of issuing aforementioned public notice to Arms License holders to approach the judicial section of undersigned to get their Arms licenses uploaded on MHA website i.e. NDAL/NDAL-ALIS;

Whereas, this office has issued Arms licenses to various individuals and Army, security Forces from time to time residing in and outside the state which are required to be uploaded on NDAL portal only up-to ***1st April 2018***" as notified by Ministry of Home Affairs vide Notification No. G.S.R 1468 (E) dated 28th November, 2017.

Whereas, no Arms license shall be renewed without having Unique Identification Number, no any other transaction shall be made on the license as per the MHA guidelines disseminated vide above quoted notification;

Whereas, the physical response regarding NDAL/NDAL-ALIS for generation of Unique Identification Number with respect to Arms license as on date is very poor which is again sought to be hastened by the medium of this notice within the stipulated time period; and

Now therefore, all the license holders who have their registration of Arms licenses in the office of undersigned are hereby informed by the medium of this notice to approach the judicial section/ NIC Udhampur of undersigned to get their Arms license uploaded on NDAL/NDAL-ALIS by or before **01.04.2018**. No license shall be entertained for generation of Unique Identification Number with respect to Arms licenses, renewal or any other transaction after the due date & time and the left out licenses shall be treated as invalid after ***1st April 2018***".
