Sub: - Login ID and password regarding NDAL/NDAL-ALIS for generation of Unique Identification Number with respect of Arms Licenses-addendum thereof

Whereas, this office vide No. 1093/DMU/JC dated 17.09.2016 issued a public notice apropos Login ID and password regarding NDAL/NDAL-ALIS for generation of Unique Identification Number with respect of Arms Licenses;

Whereas, it was made known by the medium of issuing aforementioned public notice to Arms license holders to approach the judicial section of undersigned to get their Arms licenses uploaded on MHA website i.e. NDAL/NDAL-ALIS up-to 31.03.2017;

 Whereas, this office has issued Arms licenses to various individuals and Army, security Forces from time to time residing in and outside the state which are required to be uploaded on NDAL portal only up-to 31.03.2017 as notified by Ministry of Home Affairs vide Notification No.GSR 701(E) dated 15<sup>th</sup> July- 2016;

Whereas, no Arms license shall be renewed without having Unique Identification numbers nor any other transection shall be made on the license as per the MHA guidelines disseminated vide above quoted notification;


Whereas, the physical response regarding NDAL/NDAL-ALIS for generation of Unique Identification Number with respect of Arms Licenses as on date is very poor which is again sought to be hastened by the medium of this notice within the stipulated time period; and

Now therefore, all the license holders who have their registration of Arms licenses in the office of undersigned are hereby informed by every mode of communication available to approach the judicial section of undersigned to get their

Arms license uploaded on NDAL/NDAL-ALIS by or before 31.03.2017. No license shall be entertained for generation of Unique Identification Number with respect to Arms Licenses, renewal and any other transaction after the due date & the left out licences shall be treated as invalid after 31.03.2017.
